## Model Details:

RWS1000B-12/ME, RWS1000B-15/ME, RWS1000B-24/ME, RWS1000B-36/ME, RWS1000B-48/ME  
may be followed by suffix "abcd" (a is R or S, b is CO2, c is FO, d is RF; and "a", "b", "c" and "d" may be blank)

Options "abcd" are defined as below

- a: R (control on/off to output) or S (AUX output with 5 Vdc),
- b: CO2 (thin coating (QMJU2) on both sides of printed wiring board to prevent unintentional objectives from adhering)
- c: FO (remote sensing, parallel operation, low output voltage alarm),
- d: RF (DC fan with opposite direction and air flow, and different derating curve),

In addition, there is "RFO" combination "R" and "FO".

All the combinations using the options above are available except for "R"+"RFO" and "FO" + "RFO". For "FO" and "RFO" only, transformer (T1) is used.

Suffix "S" mainly indicates AUX output with 5 Vdc, 1 A, and the associated changes below.

- Circuit diagram, silk/pattern trace layouts,
- Additional transformer (T401),
- Additional insulation sheet to keep adequate spacing,
- Alternate noise filter coil (L1), type DN-DL3626, Instead, type DN-DL3153 is not used.
- Change of shape of fan flow barrier for suffix "S" + "RF"

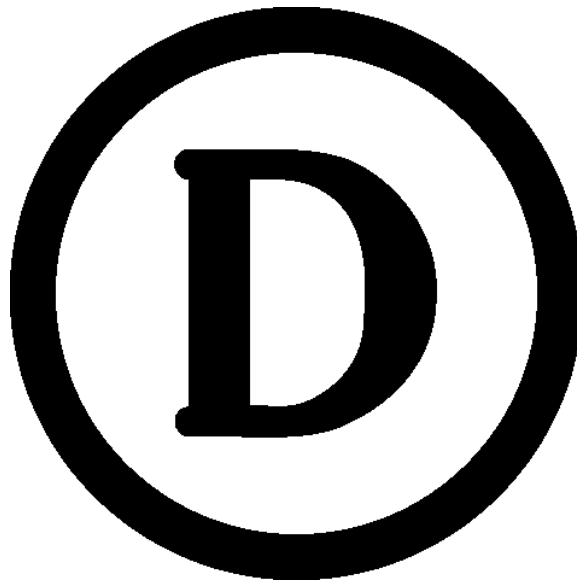
